



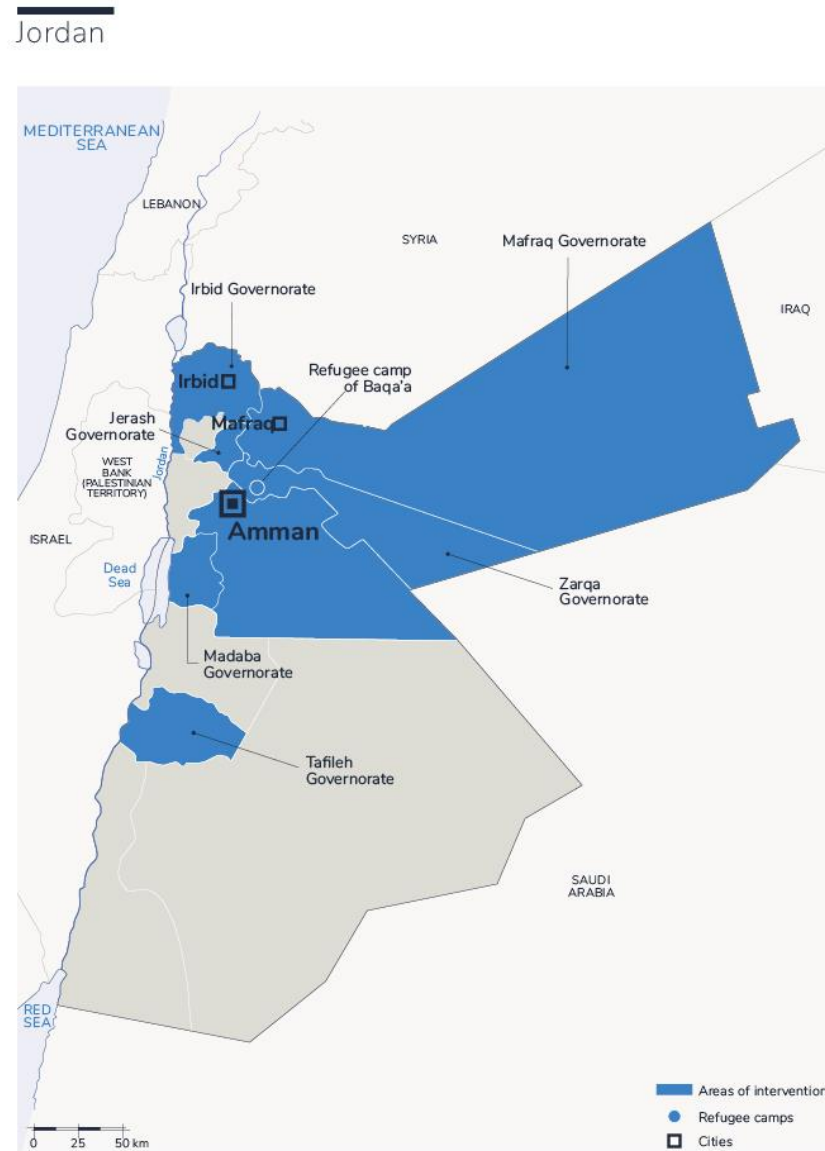

#### d. Geopolitical analysis

Jordan is classified as a high-level country on the Human Development Index, ranking 99<sup>th</sup> out of 193 countries, and as an upper middle-income country by the World Bank. Nevertheless, huge socio-economic discrepancies and inequalities remain in terms of access to rights and services.

Jordan has welcomed refugees from Syria, Iraq, Somalia, Sudan, and Yemen. Syrians are estimated to be around 1,000,000 in total in Jordan and refugees alone account for around 10% of Jordan's population. The increase in population has put pressure on local infrastructure, resources and services. Jordanians and refugees with disabilities are facing significant barriers in generating enough income for their livelihoods and in accessing education, health and other services.

Since the Gaza war began in October 2023, following Hamas' attacks on October 7, many Jordanians, particularly in Amman, show deep support for Palestinians (protests, calls to boycott, etc.). The funding crisis facing the United Nations Relief and Works Agency for Palestine Refugees in the Near East (UNRWA) also has significant implications for Jordan, as the agency directly operates multiple refugee camps and provides services to over 1 million Palestinian refugees in the country.

The escalation of conflicts involving Iran, Hezbollah, and Israel, along with the outbreak of war in Lebanon in September 2024, has intensified fears of a regional conflict. Despite these rising tensions, Jordan's security situation has remained relatively stable.

The war in Gaza and Lebanon have severely impacted the Jordanian economy, in particular the tourism sector. Since the beginning of the year, there has been a more than 60% decline in the number of tourists compared to the previous year. It is a significant impact for a sector that had already suffered from the consequences of the Covid-19 pandemic.

## Summary of HI presence in the country

HI is present in Jordan since 2002 and its activities started in 2006. HI started responding to the Syrian crisis in Jordan during the summer of 2012 and the focus was first on the provision of rehabilitation services. Starting in 2014, HI engaged in building the capacities of local actors and strengthening the Ministry of Health's system.

Today, HI Jordan works in the sectors of health (rehabilitation and early childhood development), economic inclusion, inclusive education, and the deinstitutionalization of persons with disabilities, focusing strongly on system strengthening and engaging with the Jordanian civil society. HI collaborates closely with the Ministry of Health and the Ministry of



Social Development, engaging at the policy, service provider, and community levels. Recently, HI has also begun partnering with the Ministry of Education.

HI supported the Ministry of Health in drafting the region's first Rehabilitation Strategy, which the Ministry endorsed in January 2021. HI co-facilitates the National Rehabilitation Platform, bringing together rehabilitation stakeholders, and participates in the Higher Committee for Rehabilitation and Assistive Technology. Additionally, HI assisted the Ministry of Social Development in developing referral pathways and an Early Intervention Protocol, both endorsed by the Ministry in April 2021. HI also developed a National Referral Pathway to strengthen service coordination among Ministries particularly for children with disabilities.

At the service provider level, HI builds the capacities of hospitals, primary healthcare centres, and community development centres. Support includes training healthcare staff, providing tools and equipment, and upgrading infrastructure to ensure accessible, high-quality services for persons with disabilities.

At the community level, HI operates through a network of 150 community-based rehabilitation volunteers. These volunteers identify vulnerable persons with disabilities, conduct assessments, refer individuals as needed, and provide home-based rehabilitation services. HI also supplies assistive devices, prosthetics and orthotics, and financial support to ensure that vulnerable persons with disabilities can access rehabilitation services and necessary assistive devices.

HI promotes economic inclusion by supporting persons with disabilities to access internships, vocational training, employment, and to establish home-based businesses. Working with both public and private sector partners, HI strives to create accessible internships and employment opportunities.

HI's inclusive education project targets kindergartens to provide Jordanian and Syrian refugee children with disabilities equitable access to mainstream education. This involves case management, teacher and staff training, financial assistance, and community awareness.

Finally, HI supports the Ministry of Social Development in implementing its De-Institutionalisation strategy, by piloting a project to deinstitutionalise persons with intellectual disabilities who are currently in residential care institutions, supporting their transition to living with families or in their communities.
